GENERAL INFORMATION: Animal Repellent Granular contains active ingredients that irritate animals when they touch or taste the product. This product can be used to effectively repel dogs, cats, ground hogs, squirrels, chipmunks, skunks and raccoons from treated areas for up to 30 days. This product repels by odor and taste.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

[Residential Use Packaging]

INDOORS: Use in non-living areas only (attics, basements, cellars, storage areas, garages, sheds and barns). Using gloves, lightly sprinkle granules directly from container at a rate of 0.25 lbs/15 Square Feet [Ft²] on areas to be protected. Repeat application after 30 days, if needed.

1.25 lbs will treat approximately 75 Square Feet (Ft²). [2.0 lbs will treat approximately 120 Square Feet (Ft²)] [5.0 lbs will treat approximately 300 Square Feet (Ft²)] [10.0 lbs will treat approximately 600 Square Feet Square Feet (Ft²)].

OUTDOORS: Apply on sunny, dry days. Do not apply to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply to food or feed crops.
